Good Afternoon ASC

Our beginning balance at the start of today should be \$4,606.38. This balance includes a total of \$671.87; this includes \$342.46 from literature and \$329.41 from group donations. Checks written include Ck#1132 to Robb Burch for \$12.57, Ck#1133 to Antoinette B for \$20.00 and finally a literature order of \$504.91. At this point even if the motion to write a one-time check to region for \$1000.00 passes, we are still well above prudent reserve.

Also at this point I have not moved any money over to the BB&T account; I am not comfortable making that move without direction from the body to write a check from the Carter account to the BB&T account. I know we have been directed to move accounts from the GSRs, but writing a check or going to the bank and withdrawing multiple thousands of dollars isn't a decision I'm willing to make on my own I would like to suggest, we don't move all of the money at once, I would like to leave \$200 to \$300 in the carter account for a month to make sure there are no human error mistakes that will cost the area money.

I have picked up the checks for the BB&T account so I am assuming the convention committee will be asking for their entire budget minus the \$500 check that was written to Mark T out of the Carter bank and trust account. Also

the literature orders from the group credits are being debited from the current BB&T account to help keep the books from becoming cluttered.
